- 1. - 2. Allottees are required to take "Occupation" of their quarter within thirty (30) days of conveying their "Acceptance". Failure to do so shall result in cancellation of allotment on the very next day i.e. immediately after expiry of the stipulated period of thirty (30) days and such allottees shall stand debarred from allotment of a quarter for a period of one (01) year from the date of such cancellation.
- 3.
