

Allottees are required to convey (online) their "Acceptance" of the quarter allotted to them on the QAC website <<https://qac.delhipolice.gov.in>> within fifteen (15) days from the issue of this allotment order. Failure to do so shall result in cancellation of allotment on the 16th day of issue of this allotment order and the concerned allottee shall stand debarred from allotment of a quarter for a period of one (01) year from the date of such cancellation.
2. Allottees are required to take "Occupation" of their quarter within thirty (30) days of conveying their "Acceptance". Failure to do so shall result in cancellation of allotment on the very next day i.e. immediately after expiry of the stipulated period of thirty (30) days and such allottees shall stand debarred from allotment of a quarter for a period of one (01) year from the date of such cancellation.
3. An allottee, while in "Occupation" of a quarter, if allotted another quarter and conveys "Acceptance" for the new allotment, he/she will have to deposit requisite NOCs and vacate the previous quarter within thirty (30) days of giving "Acceptance" for the new allotment failing which, the new allotment shall be cancelled immediately after expiry of thirty (30) days.
4. At the time of taking "Occupation", an allottee will have to get lodged a DD entry in the Roznamcha of the concerned PS/PC through the concerned Estate Officer. As soon as the concerned Estate Officer will enter the DD No. & Date on the QAC website, the software will generate an "Occupation" slip of which a print can be taken out by the concerned Allottee, Estate Officer as well as the QAC staff.
5. Deduction of HRA & recovery of License Fee, if applicable, shall be done from the date of "Occupation" of the allotted quarter. Similarly, a quarter will be deemed to be "Occupied" for the purpose of HRA/damage charges/license fees, till all the NOCs are submitted by the allottee at the time of vacation/surrender of the quarter.
6. Apart from the above, every allottee is required to meticulously follow other relevant instructions on the subject as contained in the Standing Order No. **Finance/01/2021**.
